**POSITION VACANCY ANNOUNCEMENT**

**Applications Accepted Beginning:** March 21, 2019.

**Application Closing Date:** Open until filled.

**Duty Station:** Brunswick, Georgia.

**Term of Employment:** August 2019 to August 2020. Exact start date is flexible.

**Starting Annual Salary Range:** JSP 11 – 13, currently \$61,218 to \$87,252, depending upon qualifications and experience. This position falls within the Judicial Salary Plan of the United States Judiciary and is therefore outside the scope of Civil Service. Salary, retirement and other benefits compare to those for employees of Civil Service.

**Qualifications:** Applicants must have graduated law school as of August 1, 2019. Legal research, writing and editorial experience is required. Familiarity with the Bankruptcy Code is desired but not mandatory.

**General Job Description:** The law clerk will be required to perform legal research, draft memoranda and opinions, counsel with Judge Kim and members of staff on legal matters affecting the administration of bankruptcy laws, and perform certain administrative duties as prescribed by Judge Kim and staff. A portion of the law clerk's time will be spent in the courtroom observing proceedings and performing other courtroom duties. Travel to other divisions located within the Southern District of Georgia may be necessary.

**Information for Applicants:** Employees of the United States Bankruptcy Court serve on an "AT WILL" basis and are required to adhere to a Code of Conduct.

- The applicant who best suits the needs of the Court will be selected.
- Due to the volume of applications received, communication will be only with those individuals who are invited to interview for the position.
- No funds are available for travel for interviews.
- Interviewees are subject to a full National Crime Information Center (NCIC) background check and FBI fingerprint analysis.

Applicants must state in a cover letter their interest in and reason for applying for this particular bankruptcy clerkship. Resume must include names, addresses, and telephone numbers of at least three references familiar with the applicant's character and/or legal ability. Resume must be accompanied by a copy of an official law school transcript that includes class rank and GPA (upper 50% standing required). If the transcript does not include this information, it should be included in the cover letter. Applicants also must submit two (2) writing samples demonstrating their legal analysis abilities. The successful applicant must reside during the clerkship term in the Brunswick, GA, Metropolitan Statistical Area.
